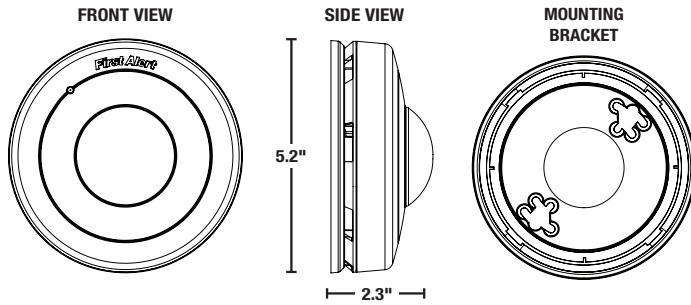

Description:

The BRK Brands, Inc. Model Number 7030BSLA (CAT 1038871) is a wire-in, 120V AC 60Hz single and/or multiple station photoelectric smoke and carbon monoxide combination alarm with integrated 177 candela LED strobe light specifically designed for residential and institutional applications including sleeping rooms of hospitals, hotels, motels, public housing, dormitories and other multifamily dwellings. Model 7030BSLA is certified to CAN/CSA STD 6.19-01 & ULC STD S531 & ULC STD S526. The alarms are inter-connectable with up to 18 devices, of which 12 can be smoke alarms. The BRK 7030BSLA alarm features a photoelectric smoke sensing chamber, an electrochemical CO sensor, an integrated 177 LED candela strobe light, an 85dB horn and sealed lithium battery capable of providing backup power for smoke and CO alarm functions over 10 year alarm life without replacement. The Strobe Light is designed to provide deaf & hard of hearing individuals with a visual warning of smoke or carbon monoxide dangers. The Smart Strobe has separate flash patterns for smoke/heat and carbon monoxide dangers. This helps a hearing impaired person better distinguish the danger present. The 177 candela LED strobe flashes at a rate of an average of 60 times a minute. The LED flash is also sync capable so when multiple LED units are installed, strobes can flash in unison.

This alarm features two latching features and two silence features. The Alarm Latch easily identifies the initiating alarm with blinking RED led pattern - even after the alarm condition has subsided. Ideal when multiple alarms are installed throughout a residence or institution. The End of Life / Low Battery Latch visually identifies which unit is in a low battery or end of life condition. The convenient silence features will temporarily silence an unwanted alarm for several minutes or eliminate low battery / end of life chirps for up to eight hours. Other Contractor preferred features include a dust cover, easy twist-lock mounting bracket with backup battery activation, and "Quick Connect" wiring harness.

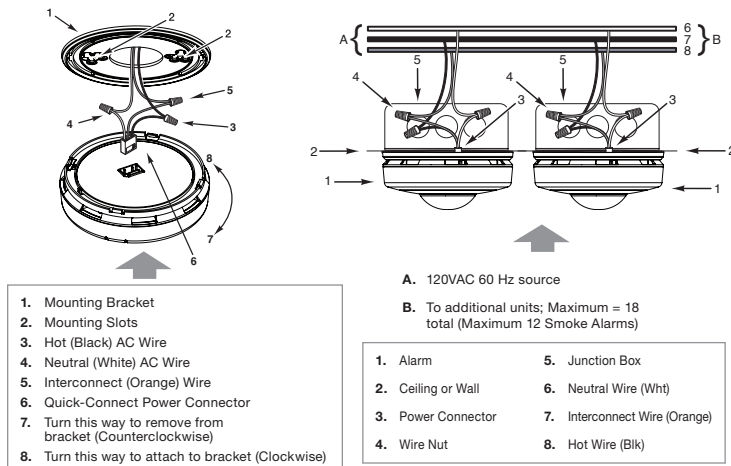
The integrated strobe light & combination smoke & carbon monoxide shall be a BRK Model 7030BSLA and shall provide at a minimum the following features and functions:

1. A photoelectric smoke sensing chamber and electrochemical carbon monoxide sensor.
2. A 177 candela LED strobe light. The Smart Strobe shall have separate flash patterns to distinguish between smoke/heat and carbon monoxide dangers. When multiple units installed, strobe flash patterns will synchronize.
3. Fully screened sensing chamber to resist entry of small insects thereby reducing the probability of unwanted alarms.
4. Powered by 120V AC, 60Hz and have a sealed 10 year lithium battery backup for alarm and a solid state piezo horn rated at 85dB at 10 ft and be capable of self-restoring.
5. A visual green LED power-on indicator to confirm unit is receiving power or is in alarm.
6. A test button should check alarm function.
7. Two Latching features: Alarm Latch to easily identify initiating alarm after alarm condition has subsided. Low battery latch: to visually identify which unit is in low battery or end of life condition. Two Silence Features: Alarm Silence to temporarily silence nuisance alarms. End of Life: Silence alarm for 8 hours.
8. The unit shall be capable of operating between 40°F (4°C) and 100°F (38°C) and relative humidity between 10% and 95%.
9. The unit shall have a plug in connector and be capable of interconnection of up to 18 units with smoke, heat, CO alarms and relays, of which 12 can be smoke alarms.
10. The unit shall at a minimum meet the requirements of CAN/CSA STD 6.19-01 & ULC STD S531 & ULC STD S526.

INSTALLATION OF ALARM

Installation of this smoke alarm must conform to all Canadian electrical code Interconnected units must meet the following requirements: wire gauge to be per local codes. It is recommended that all units be on the same fuse or circuit breaker. If local codes do not permit, be sure the neutral wire is common to both phases.

Strobe Pattern:	Smoke - Constant, approx. 1 flash per second. CO - Approx. 1 flash per second for 4 flashes, then 3 seconds off.
Silence:	Approx. 9 minutes Smoke initiating alarm, approx. 4.5 minutes CO initiating alarm, 8 hours End of Life
Alarm Latch:	Smoke - Horn off and Red LED flashing 2 seconds on, 2 seconds off. CO - Same as smoke but with 4 short red LED pulses after 2 seconds on.
Latching End of Life / Low Battery Indicator:	Green LED flashing 2 seconds on, 2 seconds off
End of Life Signal / Low Battery Signal:	3 short chirps with 5 Green LED flashes once per minute
